One component finish based on urethane alkyd resins.

Waxy finish, designed for the painting of outdoor wood structures, windows and doors. Good resistance to weathering, good wetting and film formation properties; easy brush application and high film thickness.

Finish: flat, 25-35 gloss - angle 60°(ISO 2813).

Color: clear.

Suggested DFT: 100 - 120 µm

Theoretical consumption: 180 - 220 g/m²

Practical spreading rate: roughly 30% lower than the theoretical by airless application **.

7. Application method

Equipment: brush, airless

Thinning: up to 10 % turpentine, code 903071.

Drying time:

■ Touch dry approx. 20'- 40' at 20 °C and 50% RH.

■ Hard dry approx. 24 - 36 h at 20 °C and 50% RH.

Drying times vary according to DFT, thinning and environmental conditions.

Number of coats: 1 coat as described above.

Application conditions: a pre-treatment of the surface by HOLZFREUND Impregnating (solvent borne or water borne) is recommended, followed by a light sweeping of the wood.

For exotic or difficult woods, containing tannins or other substances which may impair the film formation, the use of Insulating Dark Woods code 610021 is recommended.

Shelf life: 12 months, provided the cans are kept sealed and undamaged, into a cool and dry place with temperature between 5 and 35 °C.
Susceptible to frost damage.
